1. DATA CONTROLLER:

RedMoto Srl with head office in Via Filippo da Desio, 47 - 20832 Desio (MB).

- 2. PURPOSE OF PROCESSING:
 - a) Management of the relationship with the interested party (Customer and/or potential Customer) in relation to the purchase of Redmoto products and related processing operations (delivery, invoicing, warranty management, etc.)
 - (b) Direct and indirect marketing activities, through the forwarding of promotional communications to the data subject by means of various communication methods indicated below.
- 3. DATA RETENTION PERIODS

8. RIGHTS OF THE DATA SUBJECT

At any time, the person concerned may exercise the rights set out in Articles 15 et seq. of European Regulation No. 679/2016, namely: the right to know whether their personal data is being processed and thus to know its content and origin, to verify its accuracy or request its supplementation, deletion, limitation, updating, rectification, transformation into anonymous form or blocking, as well as the right to oppose in any case, for legitimate reasons, its processing and to lodge a complaint with the Personal Data Protection Authority.

The consent given to the processing may be revoked at any time, resulting in the interruption of the processing. These rights may be exercised vis-à-vis the Controller as identified above by sending an email to the pro-tempore Privacy Officer at info@redmoto.it.
